- Kindly apply for the e-Business Visa (e-B5V) only when all the above documents are available with you. Ministry permissions are ideally received 2 months prior to the conference dates.
- Please make sure there are enough blank pages available in passports for immigration stamping. Passport should have minimum validity of six (06) months from the date of travel/application, which is mandatory for visa processing and international travel.

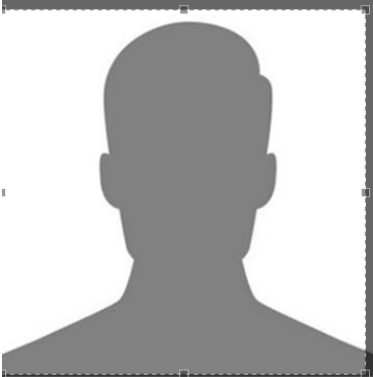
